 - (d) The successful bidder shall have to enter into an agreement with the Principal, B.S.K.College, Maithon.
 - (e) The bidder shall have to give technical bid and financial bid in two separate sealed envelopes. The bidder who shall qualify the technical bid will have the financial bid opened not otherwise.
- Validity of the quotation will be at least 3(three) months from the closing date of the enquiry.
 - Bidders must as far as possible, arrange to supply the materials within the stipulated time mentioned in the purchase order/work order. This delivery time must be strictly adhered to. Failure to supply within the specified time will lead to cancellation of the order without notice.
 - The tender must enclose copy of the Income Tax and Sales Tax Clearance certificate and Income Tax return of last 03 Financial years & Average annual Turnover of Rs. Twenty five lakh and above in the last three Financial years and should have been audited by the Chartered Accountant.
